Certification Renewal paths

Collect and log CPD points with PeopleCert Plus

Certification renewal requires accumulating 20 CPD points per year for three consecutive years and maintaining an active PeopleCert Plus Membership.

Take further courses and certifications

Candidates can also choose to keep their certifications current by attending another course and taking an exam within the same Product Suite before your certification's renewal date.

All your certifications stay current with PeopleCert Plus

01. Become a Plus member

Purchase a PeopleCert Plus Membership on peoplecert.org or get it from your Training organization.

02. Keep your Plus Membership active for 3 consecutive years

Since membership is valid for one year, remember to renew it annually.

03. Log 20 CPD points each year

Use our CPD platform within PeopleCert Plus.

At the end of the 3 years, your Certifications will be extended for an additional 3 years.

CPD points explained

Keep your certifications' currency by logging CPD points based on three categories:

Rule: 1 hour of engagement = 1 CPD point.

Complete 20 points worth of activities per year.

5 points must come from the Professional Experience category.

The remaining 15 points can be earned from activities across the Professional Education and Community categories.

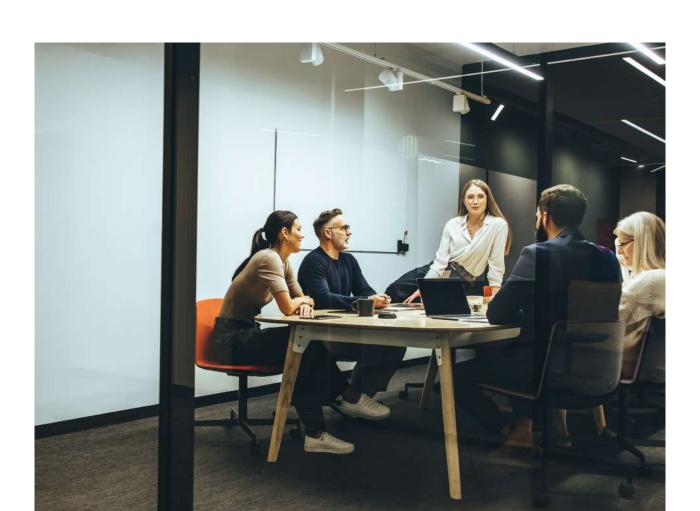

FAQs

Where can I access PeopleCert's CPD platform?

All your certifications, their "Renew by" status and CPD history are available on your PeopleCert account under the MY CERTIFICATES section.

How can I tell if my certification is up for renewal?

In MY CERTIFICATES section you can review the following statuses:

Active: the green color indicates that the certificate is active and their CPD points are up to date.

Active: the orange color indicates that certificate is active but there are pending CPD points to be added.

Not Current: the grey color indicates that the certificate is past its "Renew by" time.

What will happen if I do not log the necessary amount of CPD points for a year?

To follow the CPD renewal path you need to have an active PeopleCert Plus Membership and add 20 CPDs per year for 3 consecutive years. If for an exceptional reason you were unable to do so, please contact PeopleCert Customer Support.

I currently hold certifications from 2 certification families. Can I log the same CPD activity against both? Yes you can, as long as it is relevant for both certifications.

What is a "Relevant" CPD activity?

A relevant CPD activity is any activity that is related to the certifications you are renewing. For example, for PRINCE2 Project Management this could be listening to a project management related podcast, mentoring an aspiring project manager or even conducting a post project review.

Is it mandatory to add proof of my CPD activity?

This is not mandatory. PeopleCert's Quality team, however, audits against 10% of CPD point submissions.

What should I do if I'm currently not actively employed and cannot complete my 5 CPD points for Professional Experience?

Our CPD programme offers provisions for people that want to maintain their certification current but are unable to work. For further advice please contact PeopleCert's Customer Support.

Does my training with a PeopleCert Accredited Training Organization count as a CPD activity? Yes, it does, as a Professional Education activity.

Do events that are organized by the ATOs (Accredited Training Organizations), ATVs (Accredited Tool Vendors) and ACPs (Accredited Consulting Partners) count as a CPD activity? Yes, these events count as a Professional Education activity, with 1 CPD point per hour of engagement.
